



RESOLUTION #2014-2

A Resolution of the Washington Airport Management Association (WAMA) bestowing the title of Honorary Member on Robb Parish and Doug Sandau.

Whereas, WAMA was founded in 1970 and, via its Constitution and By-Laws, established several classes of membership; and

Whereas, one class of membership is honorary, which may be bestowed on previous WAMA members who have actively participated in the Association for at least five years and who are retiring from their active professional career, or on others who have made a significant contribution to the Association or Profession; and

Whereas, Robb Parish and Doug Sandau each meet those criteria; and

Whereas, Robb Parish served the federal Foreign Service with distinction until 1996, and, while subsequently serving as the University of Idaho Manager and Director of the Business Technology Incubator, joined the Pullman-Moscow Airport Board, and, having proved himself an able leader, was selected by that Board to serve as the Airport Manager of the Pullman-Moscow Airport for a period of eleven years until his 2011 retirement; and

Whereas, Robb Parish was an active WAMA participant during his Washington State aviation career, including service as Association President from 2008-2009; and

Whereas, Doug Sandau managed the Olympia Airport as its Regional Airport Director for a thirteen year period from 1990-2003, and, having established himself as a skilled aviation leader, was selected by Serco, Inc. to lead an international team tasked with modernizing and restoring commercial and freight service to Basra and Baghdad International Airports in Iraq from 2003-2005, and following his stateside return, served with distinction as an airport planner with URS Corporation, which then led to his return to airport management when he was selected as the Port of Port Angeles Airport and Marina Manager, a position held until his 2013 retirement; and

Whereas, Doug Sandau has been active WAMA participant throughout his aviation career, including two separate terms as a member of the Association Board of Directors book-ending his Iraq service, once in 2002-2003 and again from 2008-2009; and

Whereas, in an interesting juxtaposition of Association service, Robb Parish and Doug Sandau both served on the Association Board of Directors during 2003; and

Whereas, the WAMA Board of Directors recommends that these two individuals, who have distinguished themselves mightily in local, state, and international service, who have contributed significantly to the Association, and who have left an inspiring legacy of airport management and service in Washington State, be recognized for their stellar achievements with the awarding of the title Honorary Member; and

Whereas, the Association membership bestows the title of Honorary Member by a vote of Management members present at a regular or special meeting of the Association; **Now Therefore**,

BE IT RESOLVED by the Washington Airport Management Association:


Section 1. The Association membership hereby bestows the title of Honorary Member on Robb Parish and Doug Sandau.
